I hereby acknowledge that I have voluntarily applied to participate in, and or, observe the sport of Cowboy Action Shooting, and or, related activities including, but not limited to, entertainment, food service and merchandise vendors.

AS LAWFUL CONSIDERATION of being permitted to enter upon the premises upon which this event is conducted and being permitted to participate in, and or, observe activities or otherwise use the facilities, I, the undersigned, for my heirs, distributes, legal representatives, next of kin, and assigns agree to the provisions set torth below.

- I hereby release, waive, discharge and covenant not to sue, make claim against the property of or otherwise prosecute Fort Belmont Regulators, Des Moines Valley Sportsman's Club, it's officers, directors, agents, and or, volunteers, (for all purposes collectively referred to herein as "RELEASEES"), for liability on account of damage to the property of or injury to the person or death of the undersigned, whether caused from the passive or active negligence of RELEASEES or otherwise while the undersigned is participating in, and or, observing the sporting or related activities being presented by RELEASEES.
- II. I hereby agree to indemnify and save and hold harmless the RELEASEES and each of them from any loss, liability, damage, or cost RELEASEES may incur due to the presence of or any act of the Undersigned while the Undersigned participates in, and or, observes the sporting or related activities being presented by RELEASEES, whether caused by the passive or active negligence of RELEASEES or others.
- III. The Undersigned expressly agrees the foregoing Release, Waiver, and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Minnesota. The Undersigned further agrees if any provision of this agreement is held to be invalid, nevertheless, the balance of the agreement shall continue in full legal force and effect.

The Undersigned warrants the following statements are true and correct and understands RLEASEES HAVE RELIED ON THEM IN , ENTERING INTO THE FOLLOWING RELEASE, Waiver, and Indemnity Agreement and is giving the Undersigned permission to participate in, and or, observe the sporting and other activities being conducted by RELEASEES.
 - a) No oral presentation, statements, or inducements apart from the foregoing written agreement have been made.
 - b) The Undersigned, I am fully aware of the risks and hazards inherent in entering upon the premises where RELEASEES' events are being conducted and participating in, and or, observing any events held on said premises knowing the present condition thereof.
 - c) The Undersigned acknowledges the risk and hazards being assumed by the Undersigned may increase during the time the Undersigned is participating in, and or, observing the activities being conducted by the RELEASEES.
 - d) THE UNDERSIGNED IS AWARE THE PARTICIPATION IN, AND OR, THE OBSERVATION OF THE SPORT OF COWBOY ACTION SHOOTING WITH LOADED FIREARMS AND RELATED ACTIVITIES IS A HAZARDOUS ACTIVITY. THE UNDESIGNED DOES VOLUNTARILY PARTICIPATE IN, AND OR, OBSERVE THESE ACTIVITIES WITH THE KNOWLEDGE AND APPRECIATION OF THE DANGER INVOLVED. THE UNDERSIGNED HEREBY AGREES TO ACCEPT ANY AND ALL RISK OF PROPERTY DAMAGE, PERSONAL INJURY OR DEATH.
 - e) The Undersigned give consent to whatever medical care might be provided or available on the premise and further agrees to conform and comply with all the rules and regulations promulgated at the event.
 - f) THE UNDERSIGNED AGREES TO COMPENSATE OR REIMBURSE RELEASEES FOR ANY COSTS, EXPENSES, OR DAMAGES INCLUDING ATTORNEY FEES, RESULTING FROM ANY CLAIM BROUGHT AGAINST RELEASEE FOR PROPERTY DAMAGE, PERSONAL INJURY, OR DEATH, THAT ARISE FROM THE PASSIVE OR ACTIVE NEGLIGENCE OF THE UNDERSIGNED WHILE PARTICPATING IN, AND OR, OBSERVING THE SHOOTING EVENT, AND OR, RELATED ACTIVITIES CONDUCTED BY THE RELEASEES.
 - g) THE UNDERSIGNED HAS CAREFULLY READ AND FULLY UNDERSTANDS THE CONVENANT NOT TO SUE CONTAINED HEREIN AND VOLUNTARILY SIGNS THIS RELEASE, WAIVE OF LIABILITY, AND INDEMNITY AGREEMENT.

Should any provision of this agreement be held invalid, then the balance hereof shall remain in force and effect.

Not withstanding anything to the contrary herein, nothing contained in this agreement shall release RELEASEES from intentional or willful act on its part directly causes damage, injury or death to the Undersigned.
